

3. Introduction of Zones and Corners

【Special zone】 Digital Solutions Zone

Digital Solution for Manufacturing Industry to Support Digitalization of Value Chain
 The “Digital Solutions Zone” will be established gathering the categories such as notable AI and deep learning/cloud, 5G, 6G and communication/IoT and edge computing/VR, AR and MR/automation system and RPA among other things. This is a great opportunity of publicity for the companies concerned.



【Special zone】 Robotics Technology Zone **New**

This exhibition specially sets up the “Robotics Technology Zone”, highly praised at the ITE (INTERNATIONAL TECHNICAL EXHIBITION ON IMAGE TECHNOLOGY AND EQUIPMENT) held in December, again this year to introduce robot parts/materials, robot control, automation systems/RPA and other robot-related products and services in a big way.



【Special zone】 Space Elemental Technology Zone

With total financial support of up to ¥1 trillion, “JAXA Space Strategy Fund” fully started from FY2024. With ¥300 billion technological development support already actualized, space business is now progressing from a demonstration phase to a full-fledged commercialization phase. In the current space industry, it is essential to combine not only image processing technologies, but also various elemental technologies such as sensors, optics, communications, semiconductors, materials and control/analysis technologies. It is also highly expected to apply the industrial technologies developed in the factory automation and appearance inspection fields to the space industry. This exhibition will introduce the latest technologies and solutions as the Space Elemental Technology Zone, focusing on a wide range of fundamental and elemental technologies which support such space related business.



Optics and Laser Corner **NEW**

Optics and laser technologies are fundamental technologies essential in a wide range of fields such as manufacturing, healthcare, communications and space. They are used for micromachining, non-contact measurement, optical communications, medical diagnoses/treatments and sensing for automatic operation, supporting advancement of society and industrial innovation. They are an important key field to next-generation technologies. Japanese optics and laser technologies have a strong point in high-precision optics design and machining technologies, having high global evaluation in the measuring equipment and sensor fields. With high research and development capacity, they are capable of widely responding to medical and industrial usages. On the other hand, industrialization of basic research is not easy, leaving issues such as growth of startups and enhancement of international competitiveness. There are also concerns about aging human resources, shortage of young manpower and insufficient investments. These issues have to be solved in order to maintain sustainable technological innovation.

Advanced Elemental Technology Corner **NEW**


The elemental technologies in machine vision are the foundation supporting system performance, accuracy and reliability. With an image sensor, lens, lighting and image processing algorithm working together, it becomes possible to accurately detect and recognize a target. Advancement of each technology is essential in development of machine vision because it is directly connected to improvement of inspection accuracy and processing speed and exploitation of new usages. To maintain and enhance Japan's industrial competitiveness, highly advanced elemental technologies are indispensable, such as sensors, optics, materials and precision equipment. These technologies are the foundations of the cutting-edge fields such as AI, robots and semiconductors and directly connected to automation of manufacturing sites, quality improvement and decarbonization. Enhancement of the elemental technologies is a key to Japanese economy and technical capabilities.

Light Sources and Lighting Corner

The consultants will be assembled on later date to hold a meeting to review the consultations.



Height regulations for Package Booths and Space Only exhibits

The height of the exhibited products is allowed up to 3300 mm only for the Package Booth, Space Only (decorations up to 2400 mm). Submit the outline, drawings, etc. of the exhibit to the secretariat beforehand to consult. Please note, however, that we may not accept the exhibit in case the secretariat determines that it could affect other exhibition booths.









This type of booth includes a system panel, exhibition stand(1000(W)×500(D)×1000(H)mm), 32-inch monitor (loudspeaker and media player incorporated) and company nameplate with general font (1plate per booth).


PR images to be submitted

They will be repeatedly run without break during the exhibition period. Also, they will be publicized at the exhibition's website after the exhibition period, as with the exhibition booth PR videos to be uploaded by each exhibitor, allowing continuous PR activities not only during, but also after the exhibition period.

Exhibition Fee

● ¥180,000 (¥198,000 with tax included)

- * Display tools (System panel, display stand, 32-inch monitor (electricity usage fee included) and company nameplate with general font, business card tray) are included.

Catalog Exhibition

Exhibition Fee

● ¥30,000 (¥33,000 with tax included)

This type of plan includes a catalog stand and a company nameplate with general font (1 plate per spot).

- * The company nameplate with specified LOGOs can be ordered separately.
- * Up to 3 kinds of catalogs, etc. introducing your company, products and services are allowed to be presented in the visitors'gathering areas so that they can freely take them. (Remaining catalogs, etc. will not be sent back.)
- * Catalogs with thickness of 20 mm or more are not acceptable.
- * No attendant is allowed to be stationed.

[Special Notes]

1. Designation of the booth location

No booths can be located at your request. Please leave the decision to the secretariat.

2. Side panel (Table Top Booth/Table Top Booth with Designated Light Sources and Lighting Corner/Mini Booth)

No side panel will be installed on the passage side for the Table Top Booth located in the corner booth. If it is necessary, fill in the form with required information when applying for electrical work.

3. Prohibition of protrusions into aisles

All exhibits, decorations and equipment must not protrude into the venue aisles. All display panel stands and its mounting parts must be contained within the booth space.

4. Restrictions on floor construction

Dry pits, concrete nails, anchor bolts, etc. cannot be used on the floor.

5. Prohibitions for booth decoration, and so on

- Decoration and installed exhibit sticking out of the booth
- Bringing in and using a power strip and an extension cord
- Demonstration with a microphone and a speaker
- Behavior disturbing other exhibitors

Application Deadline March 19(Thu.). (In case there are too many exhibitors, the number of booths may be adjusted.)

■ Precautions for Entering the Exhibition Application Form

① **Firstly, select a type of booth and enter the number of booths to apply.**

- * For Package Booth, Space Only, Table Top Booth and Table Top Booth with Catalog Stand, select either "No zone specified" or "3 zones specified (Digital Solutions Zone, Robotics Technology Zone, Space Elemental Technology Zone)".
- * The Table Top Booth with Designated Light Sources and Lighting Corner is consolidated as the "Light Sources and Lighting Corner" and cannot be adjacent to other types of booths.
- * For Mini Booths, select either the "Optics and Laser Corner" or "Advanced Elemental Technology Corner".
- * For the Trial Booth, you cannot choose an exhibition zone.
- * For Video Exhibition Booth and Catalog Exhibition, you cannot choose an exhibition zone.

② **In case you want to post job information in the Job Corner, please check "Apply" under "Posting Job Information in the Job Corner" on the Exhibition Application Form to apply.**

③ **When considering technological consultation, check the box for "Participate" or "Want to hear the story" under "Technological Consultation Corner Consultant" of the Exhibition Application Form to apply.**

Cancellation Policy

In case an applicant cancels exhibition due to its convenience, an exhibition fee will not be reimbursed. A cancellation fee is 50% of the exhibition fee if cancelled up to 60 days (Apr. 11 (Sat.)) before opening of the Exhibition, and all the exhibition fee if cancelled after Apr. 12 (Sun.). In case the Exhibition is cancelled due to the convenience of the organizer, however, all the exhibition fees will be reimbursed.

Remarks




